- Adequate and cadre-wise faculty must be recruited/maintained by the institution at all times as per COA Norms.
- Faculty with PG qualifications related to specialization of the course needs to be appointed.

The institution shall initiate necessary remedial actions, if any, based on the observations of the Executive Committee & Inspection Committee and send its compliance/observations on the same for further consideration. The Council shall be at liberty to inspect the Institution at any point of time to verify the compliance made by the institution and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time. In case the institution is found to be imparting deficient education during 2021-2022, the appropriate action shall be initiated against it.
